Cybersecurity Risk Discovery and Assessment

Collaborative review, development, and definition of policies and procedures to harden infrastructure and facilitate the recovery of key assets. Includes auditing and optimizing key IT/OT network hardware architectures and software systems, identifying responsibilities and stakeholder training.



NERC Generator Owner (GO) Development and Managed Compliance Services (MCS)

Development and management of NERC GO compliance programs including corporate compliance, NERC GO compliance program development, MOD testing, CIP program development and ongoing compliance program management throughout the life of the asset.



Managed Security Services (MSS)

Ongoing management of asset operational security services, including NERC CIP, cyber health and vulnerability assessments, inventory management, patch and change management and ongoing managed security services throughout the life of the asset.
